

TOWN OF SCOTT, LINCOLN COUNTY

ORDINANCE 2014-1, DESIGNATING ATV/UTV ROUTES AND REGULATING THE OPERATION OF ATV/UTVS IN THE TOWN OF SCOTT.

SECTION 1-INTENT

THE TOWN OF SCOTT, LINCOLN COUNTY, WISCONSIN ADOPTS THE FOLLOWING ATV/UTV ROUTES FOR OPERATION OF ATV/UTVs ON THE ROADWAYS LISTED BELOW;

- SUNSET DRIVE – CTH E TO CORNING ROAD
- JOE SNOW ROAD – CORNING ROAD TO CTH K
- CORNING ROAD – NORTH OF JOE SNOW TO SUNSET DRIVE
- TANNERY ROAD – FROM JOE SNOW TO CITY LIMITS
- SCOTT ROAD – FROM CITY LIMITS TO CHURCH AVE.
- CHURCH AVENUE – FROM SCOTT ROAD TO FAIRVIEW OR CTH FF

SECTION 2-STATUTORY AUTHORITY

THE APPLICABLE PROVISIONS OF 23.33 REGULATING AN OPERATIONS PURSUANT TO ABOVE ROUTES ARE ADOPTED.

SECTION 3- CONDITIONS

AS A CONDITION FOR THE USE OF THE ABOVE ROUTES, THE FOLLOWING RULES SHALL APPLY TO ALL OPERATORS AND PASSENGERS.

1. ALL ROUTES MUST BE SIGNED IN ACCORDANCE WITH NR 64.12 AND NR 64.12(7)C.
2. ALL ATVs MUST HAVE HEAD LAMPS AND ILIGHTS ON WHEN OPERATING ON THE ABOVE ROUTES.
3. ALL ATVs MUST OBSERVE POSTED SPEEDLIMIT 35MPH.
4. ALL ATVs MUST OPERATE IN SINGLE FILE.
5. ALL ATVs MUST PROPERLY DISPLAY CURRENT REGISTRATION DECALS FOR PUBLIC USE.
6. ALL ATVs MUST OPERATE ON PAVEMENT WHERE APPLICABLE.

SECTION 4- ENFORCEMENT AND PENALTIES

THIS ORDINANCE SHALL BE ENFORCED BY ANY LAW ENFORCEMENT OFFICER AUTHORIZED TO ENFORCE THE LAWS IN THE STATE OF WISCONSIN.

PENALITES AS FOUND IN 23.33(13) (a) OF WISCONSIN STATUTES REGARDING ATVs ARE ADOPTED BY REFERENCE.

SECTION 5- SEVERABILITY

THE PROVISION OF THIS ORDINANCE SHALL BE DEEMED SEVERABLE AND IT IS EXPRESSLY DECLARED THAT THE TOWN OF SCOTT WOULD HAVE PASSED THE OTHER PROVISIONS OF THIS ORDINANCE IRRESPECTIVE OF WHETHER OR NOT ONE OR MORE PROVISIONS MAY BE DECLARED INVALID. IF ANY PROVISION OF THIS ORDINANCE OR THE APPLICATION TO ANY PERSON OR CIRCUMSTANCES IS HELD INVALID, THE REMAINDER OF THE ORDINANCE AND THE APPLICATION OF SUCH PROVISIONS TO OTHER PERSONS CIRCUMSTANCES SHALL NOT BE DEEMED AFFECTED.

SECTION 6- EFFECTIVE DATE

THIS ORDINANCE BECOMES EFFECTIVE CONTINGENT ON COMPLETION OF SIGNAGE NO EARLIER THAN JUNE 15TH 2014 IN THE TOWN OF SCOTT AS SUBMITTED BY THE SPIRIT VALLEY RIDERS AN CLUB.
